After your payment plan setup has been completed, you will receive a confirmation email from STS with your plan ID and instructions on what you can expect next.

### Financial Aid Decision Timeline

### Financial Obligation for Early Student withdrawal from the School

**Within the 1<sup>st</sup> two weeks of school:** The Responsible Payer/s will be obligated for the first month of tuition, food service and other fees.

**Prior to Thanksgiving:** The Responsible Payer/s will be obligated for one third (1/3) of the total of tuition, food service and other fees.

**After Thanksgiving:** The Responsible Payer/s will be obligated for the total of tuition, food service and other fees for the entire school year.

<sup>1</sup> Ganeinu students will not be charged Security or Food/ Textbook Fees  
<sup>2</sup> The security fee is mandatory for all students, after all scholarships have been applied. The security fee is only charged once per family.  
<sup>3</sup> Because of kosher/dietary restrictions Food Service is a mandatory fee for all students, after all scholarships have been applied.



# GoGrant Scholarship Request Form | 2024-2025

**The GoGrant Scholarship is a tuition reduction available to students in grades 1-8 who complete the GoGrant form. All qualified applicants receive a \$17,500 reduction off full tuition.**

To request the GoGrant Scholarship, this form **must** be completed and returned with the Application for Admission. The GoGrant Scholarship will be awarded only after all other scholarships/awards are deducted from the total applicable student costs. All scholarships, including the GoGrant Scholarship, cannot exceed the total applicable student costs.

# Simple Tuition Solutions

Processing Opportunity

Dear Parent or Guardian,

The Silver Academy School has partnered with Simple Tuition Solutions (STS) to Determine Eligibility for Tuition Assistance for the 2024-2025 school year.

To complete the STS Eligibility Application, please follow these 6 simple steps:

1. Click on the unique link specific to The Silver Academy:

a. If you happen to land on a page that asks you to enter a School or Scholarship Organization Code, you want to enter code: **21760**

2. If you do not already have an account with STS, you want to click on the Orange Button “Create a new account”.

\*\* If you already have an account with STS, click “Sign in”, and enter your previously created login and password. \*\*

3. Create your account

4. Upon creation of your account you will be sent to a page that will allow you to “Start a new Application”. Be sure you are selecting the proper School year.

5. The Application Process is 7 Steps, each step will save as you advance to the next step. You are able to use the 7-step tool bar across the top of the page to toggle back to a previous step and make any necessary edits. However, please note, once you complete the payment (\$25.00) at the end of the application process it will lock the application from all editing. At this point, if any changes would need to be made to the submitting application, you can gladly contact STS at **[support@simpletuitionsolutions.org](mailto:support@simpletuitionsolutions.org)**.

6. After completion of the payment process you will be advised as to which financial documents you need to provide STS. You will also be sent an email that outlines what you need to provide as well as introduce you to the application processor that will be handling the review of your application. Please Note: You can simply scan and upload your financial documents into STS’s system using STS’s convenient upload feature. This is the fastest way to provide STS with the required financial documentation. However, you can also mail the signed copies of your financial documents to STS to the following address:

Finally, once STS has received all of the required financial documentation from you, STS’s application processors will review your entire application per Pennsylvania State Law and determine your Eligibility. The Eligibility or Ineligibility results will be emailed to you directly and the Scholarship Organization and, in some cases, the school will also be notified and provided the results. It is important to note that STS is only contracted to handle the determination of Eligibility, therefore, **does not** have any input, control, or insight into scholarship amounts or when they may be awarded.

# EITC Tuition Assistance Program Information | 2024-2025

## Your child may be eligible for a scholarship to The Silver Academy through the EITC (Educational Improvement Tax Credit) Program.

Through Pennsylvania's EITC program and the support of qualifying corporations and individuals, scholarship funds become available to students at The Silver Academy whose families meet certain guidelines.

## EITC Program Terms & Definitions

### An Eligible Student

A school age student who is a resident of Pennsylvania, who is enrolled in a school located in this Commonwealth and who is a member of a household with an annual household income of not more than \$90,000, except that an additional income allowance of \$15,905 is permitted for the student and for each other dependent (as defined by the IRS) living within the same household. "School age" ranges from the earliest admission age for a school's kindergarten program (or if the school has no kindergarten program, the earliest age at which the student may begin school), through the age attained upon graduation from secondary school or 21 years of age, whichever occurs first.

### A Household

Includes an individual living alone or an individual living with the following:

- a spouse, parent and their unemancipated minor children;
  - other unemancipated minor children who are related by blood or marriage; or
  - other adults or unemancipated minor children living in the household who are dependent upon the individual.
- Household Income Calculations**  
In calculating household income for the purpose of determining student eligibility, all moneys and property received of whatever nature and from whatever source are to be included, except for the following:
- Periodic payments for sickness and disability other than regular wages received during period of sickness or disability.
  - Disability, retirement or other payments arising under workers' compensation acts, occupational disease acts and similar legislation by any government.
  - Payments commonly recognized as old age or retirement benefits paid to persons retired from service after reaching a specific age or after a stated period of employment.
  - Payments commonly known as public assistance or unemployment compensation payments by a governmental agency.
  - Payments to reimburse actual expenses.
  - Payments made by employers or labor unions for programs covering hospitalization, sickness, disability or death, supplemental unemployment benefits, strike benefits, social security and retirement.
  - Compensation received by United States servicemen serving in a combat zone.
